RESOLUTION # 2023-2

AN AMENDMENT TO NEW OXFORD MUNICIPAL AUTHORITY'S RULES AND REGULATIONS FOR WATER AND SEWER SERVICE GOVERNING THE PAYMENT OF BILLS AND COLLECTION OF DELINQUENT ACCOUNTS.

WHEREAS, the New Oxford Municipal Authority ("NOMA") desires to ensure prompt payment for the water and sewer service it provides to its customers; and

WHEREAS, NOMA recognizes that delinquencies do occur which result in the NOMA assuming and undertaking additional administrative costs, fees, and procedures (collectively "Expenses") to ensure the prompt payment of such delinquent accounts; and

WHEREAS, NOMA desires to hold delinquent customers responsible for such Expenses by seeking reimbursement for Expenses.

NOW THEREFORE, it is hereby resolved that Section 7.6 of the Water and Sewer Service Rules and Regulations of the New Oxford Municipal Authority is hereby amended to read as follows:

## Section 7.6 Delinquent Bills

Upon the expiration of the twenty-eight (28) day payment period, all delinquent bills for sewer and/or water shall be turned over to the NOMA Solicitor for collection. All unpaid bills shall become a lien on the property and entered pursuant to the Municipal Claim and Tax Lien Law, as amended, and shall include all penalties, interest as aforesaid, costs of lien and attorney's fees, including, but not limited, to the following:

2.	Ten (10) day notice letter. The collection letter fee shall include the cost of postage and will be assessed to an owner of the property.	\$25.00 per notice
3.	Drafting and filing of Municipal Claim	\$175.00 plus filing costs
4.	Lien Search	\$200.00 per search
5.	Writ of Scire Facias	\$130.00 plus filing costs
6.	Ten (10) day Notice of Default	\$ 65.00
7.	Response to Affidavit of Defense filed by delinquent owner(s)	\$215.00 per hour
8.	Judgment Documents (Inclusive) a. Praecipe of Judgment b. Notice of Filing Judgment c. Affidavit of Non-Military Service	\$150.00 plus filing costs
